Respected, Included and Nurtured: Promoting Positive School Attendance at David Livingstone Memorial Primary School



It is important for the school to work with parents in encouraging all children to attend school. All absences from school are required by law to be recorded. Absences will normally fall under two categories – authorised or unauthorised absence. In cases where children are unable to attend school parents are asked:

- To contact the school office if they know in advance of any reason why their child is likely to be absent from school.
- To notify the school first thing in the morning when a child is going to be absent, let the school know the likely date of return and keep them informed if the date changes.
- Update Parents Portal to inform the school of any change to the following:
 - o home telephone number
 - o mobile number
 - emergency contact details

Daily Attendance

Pupil attendance is monitored daily at David Livingstone Memorial Primary School. The office staff send an automated text and then make telephone contact on a daily basis to parents / carers if a pupil is absent from school. Where no personal contact is made further attempts will be made during the school day, via telephone, text and email.

Green: All pupils with attendance of 95% plus are considered to be on track. The pupils are benefitting from regular attendance at school and no further action needs to be taken.

Amber: All pupils with attendance of 85-94% are considered to be at risk of attendance becoming a barrier to attainment and achievement. The link member of the Senior Leadership Team will monitor pupil attendance and make contact on a weekly basis.

Red: Attendance is considered to be a barrier to attainment and achievement for all pupils attending less than 85%. An Attendance Support Plan will be implemented. The link member of the Senior Leadership Team will monitor pupil attendance and make contact on a weekly basis.

Monthly Attendance

Attendance at school is monitored monthly by SLT for all pupils attending David Livingstone Memorial Primary School.

90% +	 Class teacher encourages ongoing positive attendance at school. Good attendance highlighted at weekly assemblies
80-89%	 Amber Alert: Member of SLT contacts home to discuss attendance and any possible barriers to attendance.
Below 80%	 Planning meeting with member of SLT, parent and pupil to create attendance support plan. SLT monitors and encourages attendance at school and ensure Attendance Support Plan is implemented. If attendance is persistently below 80%, HT letter will be issued via post to invite parent to multi-agency planning meeting to discuss all supports available (inc. SW, SCRA). Previous attendance support plans are reviewed.
